

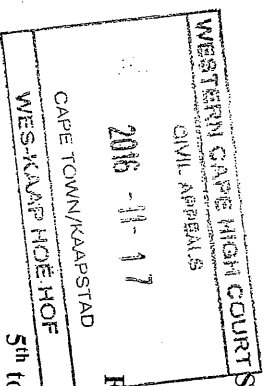

### ORDER

---

Having read the documents filed of record and having heard counsel for the parties, the following Order is made:

1. Without conceding that the exemption application/s were properly lodged through VFS, the Minister undertakes to consider and determine the exemption application/s under section 31(2)(b) of the Immigration Act.
2. Every former Angolan refugee who was issued with an Angolan Cessation Process permit ('ACP permit') may submit to Scalabrini a completed copy of the Form 47 attached to this Order (marked C and endorsed with case number 5628/16) accompanied by:
  - 2.1. a certified copy of his or her passport;
  - 2.2. an original police clearance certificate;
  - 2.3. all available documentation in support of his or her application supporting the existence of special circumstances including, but not limited to, copies of, for example:
    - 2.3.1. employment contracts (self or employees);
    - 2.3.2. educational activities;
    - 2.3.3. SARS clearance certificates;
    - 2.3.4. bank statements;
    - 2.3.5. properties and businesses; and/or
  - 2.3.6. any documents illustrating family, cultural, social and economic ties to South Africa.

3. Scalabrini will deliver the exemption applications received by it prior to 15 February 2017, to 8<sup>th</sup> floor, 120 Plein Street, Cape Town on 15 February 2017 by 09h00.
4. The Respondents will ensure that the Department of Home Affairs issues a written acknowledgement of receipt for each exemption application and the documents comprising thereof, delivered by Scalabrini, at the same time as it is delivered. Scalabrini is granted leave to approach this Court on the same papers, supplemented as necessary, on behalf of any person whose application was not accepted at 120 Plein Street, or for whose application a receipt was not issued.
5. Scalabrini undertakes to:
  - 5.1. publish this Order on its website;
  - 5.2. send an SMS message describing this Order to every former Angolan refugee who was issued with an ACP permit and whose cellular phone number is on its database;
  - 5.3. place a copy of this Order on its notice boards; and
  - 5.4. send an email version of this Order to all of its partners who work with migrants in South Africa.
6. The Minister shall consider and determine the exemption application/s having regard to all the information and documentation which has been made available to him as of close of business on 15 February 2017, including all documents and applications already received by him prior to the date of this Order.

7. The Minister shall render his decisions in writing, with:

- 7.1. full reasons in respect of any exemption application which is refused; and
- 7.2. directions as to how to collect the exemption certificate in respect of any exemption application which is granted.

8. The Minister shall ensure that his decisions are delivered by no later than 16h00 on 15 May 2017 to Scalabrini's offices at 43-47 Commercial Street, Cape Town (marked care of the Director) failing which Scalabrini is granted leave to approach the Court on the same papers, duly supplemented.

9. Up to and including 15 February 2017:


9.1. the respondents undertake not to arrest, detain or deport the second and further applicants as well as the 82 applicants listed in annexure A hereto and the 753 applicants listed in annexure B hereto, as well as any former Angolan refugee who was issued with an ACP permit;

9.2. the second and further applicants, as well as the 82 applicants listed in annexure A hereto and the 753 applicants listed in annexure B hereto, as well as every former Angolan refugee who was issued with an ACP permit, shall be entitled to:

9.2.1. work and be lawfully employed;

9.2.2. study;

9.2.3. access South Africa's primary healthcare services;

9.2.4. register the births of their children;

9.2.5. access South Africa's primary, secondary and tertiary education institutions; and

9.2.6. open and freely operate bank accounts (subject to the normal rules set by the bank in question).

10. The provisions of paragraph 9 shall, between 15 February 2017 and 15 May 2017 apply only to:

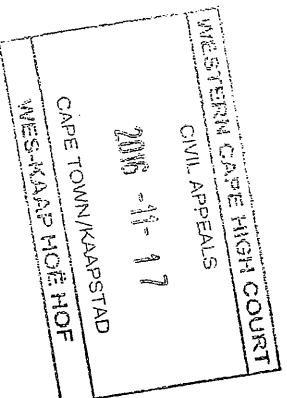
10.1. second to fourth Applicants as well as the 82 applicants listed in Annexure A; and

10.2. every former Angolan refugee who was issued with an ACP permit, and who is in possession of an acknowledgement of receipt issued in his or her name as contemplated in paragraph 4 above.

11. There is no order as to costs.
